#### TERMS AND CONDITIONS

- 1. Scope of Bid
- Dungsam Cement Corporation Limited hereinafter referred to as "DCCL" wishes to receive sealed bids from interested National bidders and non- national bidders for sale of Assets, used spares and Consumables of year 2022 &2023 located at corporate office & Various plant offices on "As Is Where Is" Basis. A list of items is given under the price schedule for sale of Asset, Used A.
- 2. Eligible Bidders
- 2.1 All interested bidders are eligible to participate in the bidding process.
- 2.2 Individuals and Firm s participating in this Tender are required to submit a copy of Citizenship Identity Card/Trade License respectively along with the Bid as a proof of their identity/establishment.
- 3. Cost of Bidding
- 3.1 The bidder shall bear all costs associated with the preparation and submission of its Bid and the DCCL shall, in no case, be responsible or liable for those costs.
- 4. Clarification of Bidding Documents
- 4.1 Prospective bidders requiring any further information or clarification on the bidding documents may notify DCCL in writing. DCCL shall respond in writing to all the bidders who have registered to any request for information or clarification of the Bidding Documents provided the request is received not later than **August 19**<sup>th</sup>, **2024.**The contact details for sending clarifications are as under:

#### 5. Amendment of Bidding Documents

- At any time prior to the deadline for submission of bids but not later than **August 26<sup>th</sup>**, **2024** DCCL may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective ebidder, modify the Bidding Documents by addendum. The amendments shall be uploaded to its website and sent to the bidders who have registered with DCCL.
- 5.2 The amendment shall be part of the Bidding Documents and will be binding on all bidders.
- 5.3 In order to allow prospective bidders reasonable time in which to take the addendum/amendment into account in preparing their bids, DCCL may at its discretion, extend the deadline for submission of bids.

#### 6. Bid Price

- 6.1 Unless stated otherwise in the Bidding Documents, sale shall be on "As Is Where Is" Basis.
- 6.2 The price to be quoted in the price schedule shall be in unit price and the total price for each item written both in figures and words.
- 6.3 Any interlineation, erasures, overwriting, cutting or alteration shall only be valid if they are initiated by the authorized signatory to the bid.
- Bidders are to quote item wise for all assets, however the evaluation will be done based on the overall amount quoted for assets. Whereas for the Used Spares and consumables bidders are to quote item wise provided bid rates are equal to or greater than reserve prices or as decided by the tender committee.

#### 7. Period of Validity of Bids

7.1 The bid shall remain valid up to **September 10<sup>th</sup>**, **2024.** The bid for the unsuccessful bidders will be returned after issuing letter of Award to the successful bidder.

# 8. Bid Security

- The bidder shall submit along with the Bid, a Bid Security equivalent to Nu/Rs 50,000.00 in the form of Demand Draft/Cash Warrant drawn in favour of Dungsam Cement Corporation Limited issued by any financial institution in Bhutan/India which is acceptable to DCCL. The bid security shall be valid up to 30 days. Non -National bidders to deposit the bid security in form of Cash.
- The Bid Security shall be submitted as a part of the Bid in a separate sealed envelope. Any bid not secured in accordance with Clause 8.1 above shall be rejected as non-responsive.
- 8.3 The Bid Security of the successful bidders shall be adjusted against the money to be deposited



for performance security.

- 8.4 The Bid Security of the unsuccessful bidders whose bid is unsuccessful shall be released upon issuance of the Letter of Award to the successful bidders.
- 8.5 The bid security shall be forfeited if:
  - i. A Bidder withdraws his/her bids during the period of bid validity specified by the bidder; or
  - ii. If a Bidder does not accept the arithmetical corrections of its bid price.

# 9. Performance Security

- 9.1 The successful bidder will then have to deposit a performance security which is 10% of the contract amount in form of cash to DCCL account on receiving the letter of award. In case the successful bidder fails to lift all the items within the time frame given by DCCL then DCCL will forfeit the performance security and cancel the contract.
- 10. Integrity Pact Statement
- 10.1 The bidder shall sign the integrity pact statement as per the format provided and submit along with the bid.
- 11. Signing, Sealing, Submission and Opening of Bids
- All the pages of the bid shall be signed by the bidder. All envelopes shall be sealed with adhesive or other sealant to prevent re-opening and each envelope shall have the NIT title and Reference number. DCCLshall not be responsible for the loss or incomplete of the bid if it is not sealed as required. The bidder shall indicate the name and address of the bidder on the envelope to enable the bid to be returned unopened in case it is declared "Late".

- Bids shall be opened on **August 26<sup>th</sup>**, **2024 at 1530 Hrs**. (BST) in the presence of any bidder(s) or their authorized representative (**one only**) who wishes to attend the bid opening.
- 11.4 DCCL shall prepare a record of Bid opening which shall include the following:

- i) NIT title and reference number
- ii) Bid submission date and time
- iii) The date, time and place of bid opening
- iv) Bid price, offered by the bidder including any discount
- v) The presence or absence of bid security and its amount
- vi) The name and nationality of each bidder
- vii) The name and signature of attendees at the Bid opening

#### 12. Late Bid

Any bids received by DCCL after the deadline for submission of the bid prescribed by DCCL, pursuant to Sub Clause 11.2 shall be declared "Late" and returned unopened to the bidder.

# 13. One Bid per Bidder

Each bidder shall submit only one bid against NIT either by self or as a partner. Any bidder who submits more than one Bid against NIT shall be disqualified.

# 14. Substitution, Modification and Withdrawal of Bids

- 14.1 The bidder's may withdraw, substitute or modify its bid after it has been submitted by sending a written withdrawal/substitution/modification notice prior to the deadline for submission of bids, duly signed by an authorized representative. The bid requested to be withdrawn shall be sent unopened to the bidder.
- 14.2 The substitution or modification of the bid must be prepared, sealed and marked in accordance with provisions under Clause 11.
- No bid shall be substituted or modified after the deadline for submission of bids.

#### 15. Correction of Arithmetical Errors in Price Bid

- Arithmetical errors shall be corrected at the time of evaluation of Price Bid and the corrected figure will be considered as evaluated Bid price. The corrections in the Bid price shall be done as per the provisions of this clause and shall be binding on the Bidder. If the Bidder does not accept the correction of errors as per the provisions of this clause, the Bid shall be rejected and the Bid security forfeited.
- If there is a discrepancy between the product of unit price and quantity for each item, and the total price, the unit price and quantity shall prevail and the total price shall be corrected unless in the

- opinion of the DCCL there is an obviously gross misplacement of decimal point in the unit rate, or ignoring to put any zero or putting any extra Zero in the unit price in which case, the total of line item as quoted shall governand unit rate shall be corrected accordingly.
- 15.3 If there is discrepancy between summation of subtotals and total price, the summation of subtotal priceshall prevail, and the total price shall be corrected.
- 15.4 If there is a discrepancy between words and figure of the total price for each item/lot, wherever the Bid document requires the figures to be written in both words and figures, the amount in words shall prevail unless the amount expressed in word has an arithmetic error.

# 16. Inspection of Disposal items

- 16.1 The bidders are expected to visit and inspect the disposal items to assess the actual conditions on "As Is Where Is" Basis during the working hours between 900 hrs. to 1700 hrs. except on Saturdays, Sundays and Government Holidays. The visit shall entirely be for inspection of disposal items. DCCL also reserves the right to postpone the visit and inspection of items and selectively allow the entry of Bidder or its authorized representative.

# 17. Rights to Accept and Reject any or all Bids

DCCL reserves the right to accept or reject any bid and to annul the bidding process and reject all bids at any time prior to award of contract, without thereby incurring any liability to the affected bidders or any obligation to inform the affected bidders of the grounds for DCCL's actions.

# 18. Letter of Award

- 18.1 DCCL shall notify the successful bidder offering the highest bid price for the contract through the issue of Letter of Award indicating the 10% of performance security to be deposited within the time frame as desired by DCCL.
- 18.2 DCCL reserves the right not to sell any Assets & PPE items if the total contract price of bidders is not equal to or more than the reserve price.

#### 19. Release of Disposal items





- 19.1 The disposal items shall be released to the successful Bidder by the authorized representatives (CSO) upon Receipt of full amount of items awarded.
- 19.2 Payment will be made in DCCL Account as and when items are being lifted

# 20. Demurrage Charges

- 20.1 The successful bidders shall complete lifting of the disposal items within sixty (60) days from the date of issue of Letter of Award. After 60 days, rental charges @Nu/Rs.500.00 (Ngultrum/Rupees Five Hundred only) per day shall be charged against each item regardless of the space occupied by the items for a period of thirty (30) days.
- 20.2 Failure to lift the disposal items within the extended period (i.e., 90 days), from the date of issue of Letter of Award, will result in forfeiture of the performance security and the cancellation of Contract.

#### 21. Damages or Losses

21.1 DCCL shall not be held responsible and accountable for any damages or losses caused to the items for which payment has been made, but not lifted within 60 (sixty) days from the date of issue of Letter of Award.

# 22. Quantity Variations

22.1 Quantities variations, if any during the final measurement of the Assets shall be adjusted by depositing additional money to the DCCL's account in case of plus (+) variations, if acceptable to the bidder; or refunding the excess money deposited by the successful bidder in case of minus (-) variations as the case may be.

#### 23. Transportation

- 23.1 The successful Bidder shall make its own arrangement to lift and transport the disposal items after the issuance of Letter of Award. Incase DCCL machineries are used by the successful bidder for the loading purpose then the cost for the same to be borne by the successful bidder.
- 23.2 For loading purpose, DCCL will not be responsible for any delays due to not availability of machineries which have been deployed by DCCL in the Plant.

#### 24. Taxes & Duties

24.1 The successful Bidder shall be responsible to pay statutory taxes, duties and levies, etc. which may arise inconnection with this Contract.

# 25. Dispute Resolutions

The party shall be in good faith resolve disputes arising out of the contract through negotiated settlement. In the event, parties cannot reach an amicable settlement through negotiation within 60 days of the first notice to negotiate, the parties shall initiate judicial proceedings in the Royal Court of Justice, Nganglam, where, in either of the party's opinion, such judicial proceedings are necessary to preserve their right.

# **Section II (2) INTEGRITY PACT**

#### 1. General

# 2. Objectives

Now, therefore, the DCCL and the bidder agree to enter into this pre-contract agreement, here in after referred to as integrity pact, to avoid all forms of corruption by following a system that is fair, transparent and free from any influence/unprejudiced dealings prior to, during and subsequent to the currency of the contract to be entered into, with a view to:

- 2.1 Enable the DCCL to obtain the desired contract at a reasonable and competitive price in conformity to the defined specifications of the works, goods and services; and
- 2.2 Enable bidders to abstain from bribing or any corrupt practice in order to secure the contract by providing assurance to them that their competitors will also refrain from bribing and other corrupt practices and the DCCL will commit to prevent corruption, in any form by their officials by following transparent procedures.

#### 3. Commitments of the DCCL

The DCCL commits itself to the following:

- 3.1 The DCCL hereby under takes that no official of the DCCL, connected directly or indirectly with the contract, will demand, take a promise for or accept, directly or through intermediaries, any bribe, consideration, gift, reward favour or any material or immaterial benefit or any other advantage from the Bidder, either for themselves or for any person, organization or third party related to the contract in exchange for an advantage in the bidding process, bid evaluation, contracting or implementation process related to the Contract.
- 3.2 The DCCL further confirms that its officials shall not favor any prospective bidder in any form that could afford an undue advantage to that particular bidder during the tendering stage, and will further treat all Bidders alike.
- 3.3 All the officials of the DCCL shall report to the Chief Executive Officer, DCCL, any attempted/completed violation of clauses 3.1 and 3.2.

3.4 Following report on violation of clauses 3.1 and 3.2 by official (s), through any source, necessary disciplinary proceedings, or any other action as deemed fit, including criminal proceedings may be initiated by the DCCL and such a person shall be debarred from further dealings related to the contract process. In such a case while an enquiry is being conducted by the DCCL the proceedings under the Contract would not be stalled.

#### 4. Commitments of Bidders

The Bidder commits himself to take all measures necessary to prevent corrupt practices, unfair means and illegal activities during any stage of his bid or during any pre-contract or post-contract stage in order to secure the contract or in furtherance to secure it and in particular commits himself to the following:

- 4.1 The Bidder will not offer, directly or through intermediaries, any bribe, gift, consideration, reward, favour, commission, fees, brokerage, any materials or immaterial benefit to any official of the DCCL, connected directly or indirectly with the bidding process, or to any person, organization or third party related to the contract in exchange for any advantage in the bidding, evaluation, contracting and implementation of the Contract.
- 4.2 The Bidder further undertakes that he has not given, offered or promised to give, directly or indirectly any bribe, gift, consideration, reward, favour, commission, fees, brokerage, any material or immaterial benefit to any official of the DCCL or otherwise in procuring the Contract or forbearing to do or having done any act in relation to the obtaining or execution of the Contract or any other contract with the Company for showing or forbearing to show favour or disfavour to any person in relation to the Contract or any other contract with the Company.
- 4.3 The Bidder will not collude with other parties interested in the contract to preclude the competitive bid price, impair the transparency, fairness and progress of the bidding process, bid evaluation, contracting and implementation of the contract.
- 4.4 The Bidder, either while presenting the bid or during pre-contract negotiations or before signing the contract, shall disclose any payments he has made, is committed to or intends to make to officials of the DCCL of their family members, agents, brokers or any other intermediaries in connection with the contract and the details of services agreed upon for such payments.
- 4.5 The bidder shall not enter into any monetary dealings or transaction, directly, with any tender committee member, and if he does so, the DCCL shall be entitled forthwith to rescind the Contract and all other contracts with the bidder.

#### 5. Sanctions for Violation

The breach of any aforesaid provisions or providing false information by DCCL, including manipulation of information by evaluators, shall face administrative charges and penal actions as per the existing relevant rules and laws.

The breach of the Pact or providing false information by the Bidder, or any one employed by him, or acting on his behalf (whether with or without the knowledge of the Bidder), or the commission of any offence by the Bidder, or any one, employed by him, or acting on his behalf, shall be dealt with as per the provisions of the Penal Code of Bhutan, 2004, and the Anti – Corruption Act, 2006.

In the event of a breach, the DCCL shall also take all or any one of the following actions, wherever required:

- 5.1 Immediately call off the pre-contract negotiations without giving any compensation to the Bidder. However, the proceedings with the other Bidder(s) would continue.
- 5.2 Immediately cancel the contract, if already awarded/signed, without giving any compensation to the Bidder.
- 5.3 Forfeit the Earnest Money/security deposited with the DCCL.
- 5.4 Recover all sums already paid to the Bidder.
- 5.5 En cash the advance bank guarantee and performance bond /warranty bond, if furnished by the bidder, in order to recover the payments, already made by the DCCL, along with interest.
- 5.6 Cancel all or any other Contracts with the Bidder.
- 5.7 Debar the Bidder from entering into any bid from the Company as per the Debarment Rule.

#### 6. Examination of Books of Accounts

In case of any allegation of violation of any provisions of this integrity pact or payment of commission, the DCCL/authorized persons or relevant agencies shall be entitled to examine the Books of Accounts of the Bidder and the Bidder shall provide necessary information of the relevant financial documents and shall extend all possible help for the purpose of such examination.

# 7. Monitoring and Arbitration

The Company shall be responsible for monitoring and arbitration of IP as per the procurement rules.

- 9.2 Should one or any provision of this pact turn out to be invalid, the remainder of this pact remains valid. In this case, the parties will strive to come to an agreement to their original intentions.


