- The sealed and signed offer should reach the Managing Director/CEO of M/s. Dungsam Cement Corporation Limited no later than 10th Feb, 2025 or summit the quotation through password-protected offers to procurement@dccl.bt. Or <u>Dorji.wangchuu768@dccl.bt</u>. The bids will be opened on the same day. Any offers received after the deadline will not be accepted and will be considered invalid.
- All bidders must quote their rates in accordance with the specifications mentioned above, and items that do not meet these specifications will be considered invalid.

3. Bid Security

a. The Bid Security Amount shall be a Bid Security of 10% of the quoted amount in the form of Cash Warrant/Demand Draft/Bank Guarantee, addressed to MD/CEO, DCCL, and Nganglam with validity period of three months from the date of Opening. Further, it will be retained as performance security till the expiry of contract. If the supplier fails to deliver the material within the grace period of one month, the order shall be cancelled with forfeiture of Performance security. Instead of providing a Bid Security, the bidder must submit the Bid Securing Declaration Form - FORM NO.1.

- b. Forfeiture of Bid Security
- a. If a bidder withdraws its bid during the period of bid validity,
- b. If a successful bidder does not accept the arithmetical correction of its bid price.
- c. In the event of forfeiture of the bid securing declaration, the bidder shall be required to provide the bid security amount in the form of a cash warrant or a Bank Guarantee issued by a reputable financial institution within 14 days from the date of notification by DCCL. Failure to comply with the aforementioned requirement will result in the bidder being barred from conducting business with DCCL.
- If the specifications provided are unclear, bidders must not quote a rate until they have sought clarification from the Procurement Section.
- 5. The final delivery point for the materials will be the DCCL Store, and the delivery period for the goods must be within 20 days for Group B, For Group A & C 25 days of the purchase order's issuance. The materials must conform to the specifications above, and failure to do so will result in rejection and replacement at the supplier's cost. In the case of rejected items, they must be replaced as soon as possible, but the delivery period shall remain the same.
- 6. The quoted price must be inclusive of all taxes and duties in Bhutan and wherever applicable.
- 7. A delay in the delivery of goods will result in Liquidated Damages of 0.3% per day, up to a maximum of 10%. In such cases, the LD will be calculated based on the total value of the items for which the supply has been delayed.
- 8. In the event of material rejection, the supplier shall replace or lift the rejected items within 10 days from the date of receiving the rejection notice from DCCL. Failure to do so will result in a penalty of 0.03% of the quoted value, which shall be applied for up to 30 days. If the replacement or lifting of the rejected items exceeds 30 days, the items shall be seized and become the property of DCCL. Additionally, the order shall be cancelled, and the performance security will be forfeited.
- 9. The items are categorized into three groups: Group A (ABB Items), Group B (Mixed Items), and Group C (Manufacturer Items). Orders will be placed based on the lowest total amount for each group. Bidders are encouraged to quote for any group; however, rates must be provided for all items within the selected group(s) without leaving any item unquoted, Failure to quote any single item in a group will result in the bid being invalid or non-responsive.
- 10. Payment will be made within one month of the materials' delivery, and no advance payment will be made.
