Terms and Conditions

- Password protected offer shall be submitted @ procurement@dccl.bt on or before 2nd June, 2025 by 3:00 pm (BST) and opened on the same day by 3:30 pm (BST). The offer received after the dateline shall not be accepted and consider invalid.
- 2. All the bidders are required to quote your rate as per the above-mentioned specifications/Make and items not fulfilling the specifications shall be treated as invalid.
- 3. If the specification provided is not clear, the bidders shall not quote the rate unless clear specification is sought from the Procurement Section.
- 4. Final delivery point of materials shall be at DCCL, Store. The delivery period of goods shall be within 30 days from the date of issuance of the purchase order. The materials shall confirm the above specifications, failing which it shall not be accepted and replacement has to be made at the cost of supplier. In case of rejected item, it shall be replaced within 20 days from the date of notice from DCCL office. Non replacement of materials shall be seized by DCCL with the cancellation of the supply order.
- 5. The price quoted shall be inclusive of all taxes in India and Bhutan. However, if the supplier has quoted the rate exclusive of Bhutan Tax, DCCL shall estimate 10% Tax on the quoted rate and accordingly calculate the lowest bidder. Additionally, any Bank charges shall be borne by DCCL.
- 6. Delay in delivery of goods shall be liable for Liquidated Damage of @ 0.1% per day subject to maximum of 10%. In such cases LD shall be calculated on the total value of item for which supply has been delayed.
- 7. The order shall be placed based the competitive pricing and terms. All quotation submitted will be evaluated on cost, quality, warranty or guarantee and compliance with the specifications and delivery timelines
- 8. The payment shall be made within one month upon delivery of materials. No advance payment shall be made.
- 9. If the successful bidder fails to supply the materials after receiving the supply order, DCCL shall forfeit 10% amount value of the order from other bills of your company (If any) or deduct the amount from the upcoming bills.







- 10. No other terms and condition shall be entertained.
- 11. Deviation of any terms & conditions mentioned shall lead to rejection of the bid during the time of evaluation.
- 12. The DCCL reserves the right to accept or reject the quotation without assigning any reason thereof.
