Terms and Conditions

1. The sealed and signed offer should reach the Managing Director/CEO of M/s. Dungsam Cement Corporation Limited no later than 5th June, 2025 or submit the quotation through password-protected offers to procurement@dccl.bt on or before 3:00 pm (BST). The bids will be opened on the same day at 3:30 pm (BST). Any offers received after the deadline will not be accepted and will be considered invalid.
2. All bidders are required to quote your rates as per the above-mentioned specifications/Make and items that do not fulfilling the specifications will be considered as invalid.
3. If the specifications provided are unclear, bidders must not quote a rate until they have sought clarification from the Procurement Section.
4. The final delivery point for the materials will be the DCCL Store, and the delivery period for the goods must be within 30 days of the purchase order's issuance. The materials must conform to the specifications above, and failure to do so will result in rejection and replacement at the supplier's cost. In the case of rejected items, it must be replaced within 20 days from the date of notice from DCCL's office, but the delivery period shall remain the same. Non replacement of materials shall be seized by DCCL with cancellation of supply order.
5. The quoted price must be inclusive of all taxes and duties in Bhutan and wherever applicable. However, if the supplier has quoted the rate exclusive of Bhutan Tax, DCCL shall estimate 10% Tax on the quoted rate and calculated the lowest bidder. Additionally, any bank charges should be in DCCL's scope.
6. A delay in the delivery of goods will result in Liquidated Damages of 0.3% per day, up to a maximum of 10%. In such cases, the LD will be calculated based on the total value of the items for which the supply has been delayed.
