- 4. The final delivery point for the materials will be the DCCL Store, and the delivery period for the goods must be within 30 days of the purchase order's issuance. The materials must conform to the specifications above, and failure to do so will result in rejection and replacement at the supplier's cost. In the case of rejected items, it be must be replaced within 20 days from the date of notice from DCCL's office, but the delivery period shall remain the same. Non replacement of materials shall be seized by DCCL with cancellation of supply order.
- 5. The quoted price must be inclusive of all taxes and duties in Bhutan and wherever applicable. However, if the supplier has quoted the rate exclusive of Bhutan Tax, DCCL shall estimate 10% Tax on the quoted rate and calculated the lowest bidder. Additionally, any bank charges should be in DCCL's scope.
- 6. A delay in the delivery of goods will result in Liquidated Damages of 0.3% per day, up to a maximum of 10%. In such cases, the LD will be calculated based on the total value of the items for which the supply has been delayed.
- 7. If the successful bidder fails to supply the materials after receiving the supply order, DCCL shall forfeit 10% amount value of the order value from the other bill of your company (If any) or deduct 10% from the upcoming bills.
- 8. The order shall be placed based on lowest quoted rate of the item.
- 9. Payment will be made within one month of the materials delivery, and no advance payment will be made.
- 10. Deviation from any of the terms and conditions mentioned above will lead to the rejection of the bid during the evaluation period.
- 11. The DCCL reserves the right to accept or reject any quotation without providing a reason.
