3. Specification Compliance

5. No Clarification Post Order

6. Payment Terms

Payment will be made only after delivery of the materials. No advance payment shall be made under any circumstances.

7. Delivery Terms

- o The final delivery location is DCCL Store.
- The expected delivery period is within 2 weeks from the date of issuance of the Purchase Order.
- However, considering the nature of certain items, if delivery within 2 weeks is not feasible, DCCL may propose a realistic delivery timeline. This decision shall be at the discretion of DCCL based on practicality.
- All materials must meet the required specifications. Non-conforming items will be rejected and must be replaced at the supplier's cost within the original delivery timeline
- Failure to replace rejected items within the stipulated time will result in forfeiture of performance security or 10% order value from your running bill.

8. Pricing and Taxes

- o Prices must be quoted inclusive of all Indian taxes and duties.
- For Bhutanese bidders, the Bhutan Taxes (BST and Custom Duty) must be included in the quoted prices.
- For international bidders, Bhutan taxes shall be in DCCL's scope.
- During evaluation, the Bhutan taxes component shall be appropriately calculated and considered

- The replacement of the rejected material should be carried out as per the original time frame as stipulated in the purchase order.
