
Interested bidders are required to physically inspect the vehicle before participating. Submission of the bid will be considered as full acceptance of all terms and conditions without any objection.

#### TERMS AND CONDITIONS

- 1. The bid form must be submitted in a sealed envelope addressed to the CEO, Dungsam Cement Corporation Ltd., Nganglam. For bids submitted via email, a scanned copy of the signed bid form along with a screenshot copy of the EMD deposited must be attached.
- 2. The envelope containing the sealed bid must be marked as:
- "DCCL Scaled Bid for Water Tanker"
- "Do Not Open Before: 3:30 PM on 25th December 2025"
- 3. Each page of the bid form must be duly signed by the bidder. Non-signing on all the pages of bid form will result in rejection of bid.
- 4. The bid form must be submitted to the Reception Desk latest by 3:00 PM, 25th December, 2025 and the tender will be opened at 3:30 PM on the same day at DCCL Conference Halls and awarding of winning shall be done on the same day.
- 5. The bidders have to deposit an earnest money of Nu. 15,000. for the Water Tanker in the form of demand draft or cash warrant addressed to CEO, Dungsam Cement Corporation Ltd, Nganglam along with the bid form. Any bid not accompanied by acceptable EMD shall be rejected.
- 6. The earnest money of the successful bidders will be retained until the successful bidder deposits the full bid amount. The earnest money of the successful bidder will be returned upon depositing the full bid amount.
- 7. The earnest money of unsuccessful bidders will be refunded immediately after the decision is made by the tender committee to sell the vehicle at the quoted price or not.
- 8. The carnest money of the successful bidder will be forfeited if the successful bidder does not deposit the 100% bid amount within 10 working days from the date of acceptance and the bid will no longer be valid.
- 9. The EMD shall be forfeited if the bidder withdraws its bid after the bid opening.
- 10. It will be assumed that the bidder has inspected the vehicle and is satisfied with the vehicle condition. The item are offered for auction and will be sold "AS IS WHERE IS BASIS" without representation, warranty, or guarantee as to the quality, condition, size, or kind, or that the same is in condition, or fit to be used for the purpose for which intended, and no claim for any allowances or deduction upon such grounds shall be considered after the bid opening or bid is awarded.
- 11. Inspection of the vehicles shall be allowed strictly from 11<sup>th</sup> to 25<sup>th</sup> December, 2025 during office hours. No inspection shall be allowed thereafter. Complaints of any mismatch of the condition of the vehicles will not be entertained later.



- 12. The vehicles may be inspected at the respective Dungsam Cement Corporation Ltd Office Premise during office hours.
- 13. The successful bidder shall lift the vehicle on the day of Final Payment at their own cost.
- 14. After the final payment day is lapsed, a demurrage charge of Nu. 500 shall be imposed on every day.
- 15. The successful bidder shall be liable to pay all statutory taxes and duties applicable in the Kingdom of Bhutan for the transfer of the properties.
